**SUPPLEMENTAL APPROPRIATION RELATIVE TO THE ANNUAL APPROPRIATION ORDINANCE**

**FOR THE FISCAL YEAR MAY 1, 2016 TO APRIL 30, 2017 PASSED BY THE CITY COUNCIL**

BE IT ORDAINED BY THE CORPORATE AUTHORITIES OF THE CITY OF WAUKEGAN, ILLINOIS:

WHEREAS, the City of Waukegan (City) is a home-rule unit under subsection (a) of Section 6 of Article VII of the Illinois Constitution of 1970; and as such it may exercise any power and perform any function pertaining to its government and affairs for the protection of the public health, safety, welfare, and morals; and

WHEREAS, the Community Development Block Grant (CDBG) Division of the has access to funds from the United States Department of Housing and Urban Development (HUD) earmarked for public infrastructure improvement projects following certain federal guidelines; and

WHEREAS, the availability of said funds were identified after the passage of the City's Annual Appropriation Ordinance; and

WHEREAS, the current Appropriation Ordinance provided only for Motor Fuel Tax Revenues and General Obligation Bond Proceeds to fund street renewal and replacement projects for the current fiscal year; and

WHEREAS, the City desires to augment the street renewal and replacement projects for the fiscal year with said HUD funds.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL, OF THE CITY OF WAUKEGAN, ILLINOIS, as follows:


Section 1: The Appropriation Ordinance of the City of Waukegan, Illinois for the fiscal year beginning May 1, 2016 and ending April 30, 2017 is hereby supplemented and increased by the amount of \$915,246.00 (Appendix A attached hereto).

Section 2: All unexpended balances of the appropriations for the fiscal year ending April 30, 2017, are hereby specifically re-appropriated for the same general purposes for which they were originally made.

Section 3: This ordinance shall be in full force and effect pursuant to ILCS 65/1-2(5)(6).
